

# **Christmas Mini Photoshoot Session Contract 2025**

### **ENTIRE AGREEMENT**

Photographer agrees to take photographs per Client's request, allowing for artistic expression. Photographer agrees to create high quality photographs and will use professional hand editing to edit digital images to represent photographer's artistic style not dissimilar to what has been publicly displayed and viewed by Client on website littlegemsphotography.com.au and relevant social media pages.

### **BOOKING DEPOSIT AND FEE**

At the time of the booking, Client agrees to pay a non-refundable deposit of \$100 to secure the session date/time. The deposit amount will be applied towards the session fee. Photographer will provide a URL with which Client can view low resolution, watermarked non-downloadable files within 3 weeks of the session date. Upon payment of the final instalment, selected photos will be provided as downloadable files in full resolution.

### **SESSION TYPE**

The Christmas Mini Session Early bird fee of \$225 includes a 20-minute photography session. Client has the option to have photos taken in front of both the Peppermint Plaza Setup and Christmas Window Setup. The price includes 6 digital images in full resolution as digital downloads. Additional digital photos can be purchased for \$20 per file, or 3 files for \$50. Prints can be ordered via a print store, which is linked to the viewing gallery.

## **CANCELLATION POLICY**

If cancellation is initiated by Photographer, all monies including the deposit fee will be returned to Client within 5 business days from the time of cancellation. If Client cancels this agreement or fails to show, the deposit shall be forfeited. Client understands and agrees that Photographer will not book other sessions dates during this time.

# **RESCHEDULING / LATE ARRIVALS**

In the event Client requests to reschedule a session, the deposit shall be applied to a rescheduled session if notice is given at least 7 days prior to the original scheduled booking date. Rescheduling must be within the same calendar year and is subject to availability. Any client that is late arriving to the allocated session date/time may forfeit the deposit.

# **IMAGE FILES**

Upon receipt of the final payment, the images will be available for download for 6 weeks. Client is responsible for downloading their images in a timely manner. Administration fees may apply to reinstate downloadable images after 6 weeks. Photographer cannot guarantee the images will be kept beyond a 12-month period.



### **CLIENT USAGE**

Client shall only use the prints, including digital files in accordance with the permissions within this agreement. Printing rights are granted. Client's prints are for personal use only and shall not be submitted into contests, reproduced for commercial use or authorise any reproductions by parties other than the Photographer. Client must not post self-edited/filtered images on social media.

### **FAILURE TO PERFORM**

If Photographer is unable to perform this agreement due to illness, emergency, fire, casualty, strike, act of God or causes beyond control of Photographer, Photographer and Client shall make every attempt to reschedule the session. If a reschedule is unable to be agreed upon, Photographer shall return the deposit to Client and shall have no further liability. Further, if Photographer is unable to delivery photographic materials due to technological malfunctions, included but not limited to camera and processing, or otherwise lost or damaged without fault of the photographer, liability shall be limited.
